### DCU's Big Win


There was a big celebration with plenty of food for the District Court Unit (DCU) recently. Through hard work and long hours, they conquered the backlog of 8,000 referrals and are now current. (more below)



It started in early 2019 when Leah Taguba and David Baker talked about organizing and redoing DCU's stats using Baker's new data analysis tools. Having the tools helped them drill down, see patterns and then strategize the best and most effective solutions. Ultimately they saw an opportunity to address a real issue. Having a backlog is a community safety issue as well as a time of uncertainty for the accused.

The DCU team tackled the problem. For nine solid months, filers, trial DPAs, staff and recent grads worked diligently to manage the backlog. Going forward: DUIs and "person crimes" are being processed within days of referral and decisions on cases are made on cases we had historically deprioritized. Now communities are safer and we are prosecuting crimes in real time. Thanks to everyone in the District Court Unit for all the work that went into this achievement.



### Thank You Note for DPA Danika Adams

We rarely get thank you notes, but DPA Danika Adams did. Patrick Hinds shares the story:

A long-time property/maintenance manager for an HOA in Redmond was charged with unauthorized use of the HOA credit cards. That's where the case started, but as Danika and her team dug in, they realized it was much more than that.

"If we knew then what we know now, it likely would have been filed and handled as a pre-assigned Complex Fraud case," said Patrick.

Danika worked closely with the HOA presidents and treasurer and, after a nearly two-year odyssey, 600 pages of exhibits, finally a resolution was reached with Judge Amini.

Danika did a great job with it and was ultimately able to get a plea, a jail sentence, and over \$180,000 in restitution (actually paid, not just ordered). The victims were quite pleased, as you can tell from this email from John Eisen, the HOA's president.

*"I thought I would mention something that happened tonight, at our annual Cedar Ridge homeowners meeting, I learned about the fate of our former property manager--he used Cedar Ridge funds for his himself. Danika did amazing work -held her ground. This person, Warren, was convicted of First Degree Theft, paid our CR insurance company \$170,000 plus he paid Cedar Ridge \$8,500, plus 15 days in jail (that was very unexpected) and 45 days of being monitored.*

*The interesting event that led to Warren's being discovered was a receipt from a sport store. He purchased a 9 mm handgun. That receipt led our board treasurer to start looking at other receipts. As reported tonight, in a bit of irony, what started this whole uncovering was Warren buying a gun, now he is convicted felon, now he cannot own a gun.*

*Having worked as a paralegal in VISTA and helping to assist an attorney with criminal cases, I know our courts provide the opportunity for justice, but it may not always happen, yet in this case, I felt this was a good outcome.*

*It must be fun working with people like Danika."*



For her part, Danika had high praise for the past and current presidents and the treasurer of the HOA.
